

## WOMEN'S FUND OF PORTER COUNTY 2024 GRANT GUIDELINES

The Porter County Community Foundation strengthens our community through lasting generosity and leadership. The *Women's Fund of Porter County* offers an opportunity for women in Porter County to collectively share the joy of giving and address the most important needs of women and children in our community—together.

The **Women's Fund of Porter County** funds programs that demonstrate positive outcomes in improving the lives of women and children. A volunteer Grant Committee will review all submitted applications and award grants.

The *Women's Fund of Porter County* welcomes nonprofit organizations serving Porter County to submit a grant request. Recipient organizations must be organized for tax exempt purposes as set forth in Section 501(c)(3) of the Internal Revenue Code of 1986.

Recipients of a **Women's Fund of Porter County** grant are **not** permitted to reapply in the year following the award.

### Please note that project areas NOT considered for funding include the following:

- Projects or programs that do not address issues facing women and/or children;
- Scholarship programs including daycare and program participation fees;
- Annual appeals or membership contributions;
- Event sponsorships;
- Programs that are sectarian or religious in nature;
- Political organizations or candidates;
- Contributions to endowment campaigns;
- Campaigns to reduce previously incurred debt;
- Individuals;
- Programs already completed and/or equipment already contracted for; and
- Travel for bands, sports teams and similar groups.

Proposals for a *Women's Fund of Porter County* grant must be submitted no later than 12:00 p.m. (Noon) on June 28, 2024.
